- Anti-tilt runners accept GN 1/1 containers.
- Self closing stainless steel doors (< 90°).

- Internal structure with 15 charging positions (3 cm pitch) available to host GN 1/1 grids, ensuring higher net capacity and a greater storage space.
- Internal and external doors, front and side panels and removable worktop in AISI 304 Stainless steel.

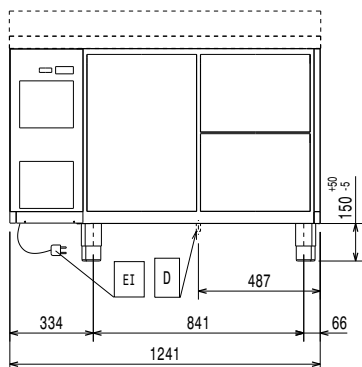

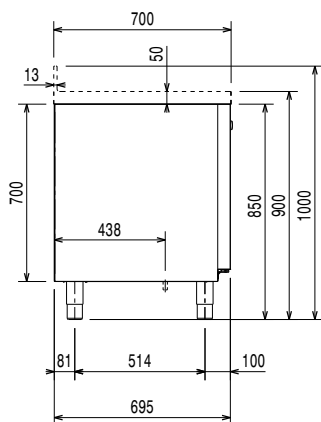

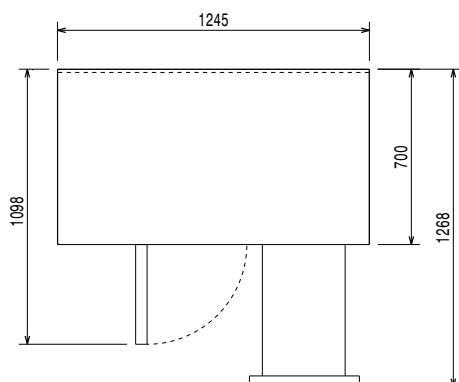
