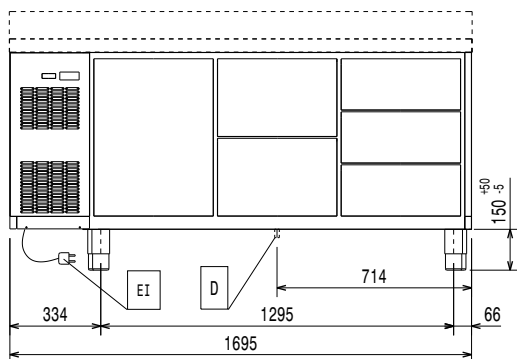

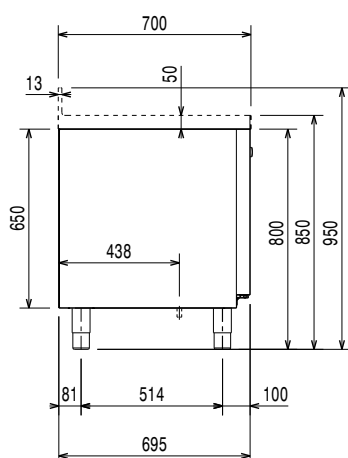

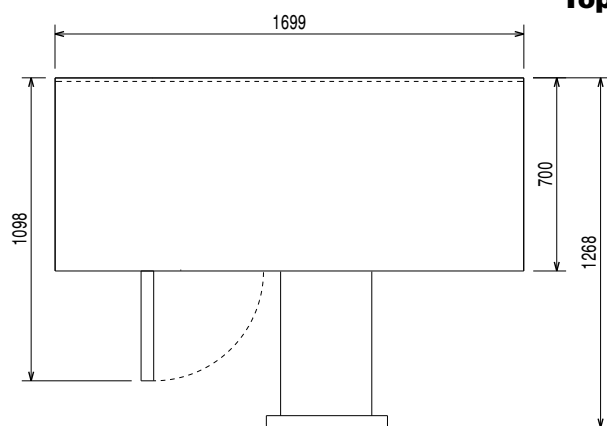


Side
