Construction

- Interior base with rounded corners, pressed from a single sheet.
- If needed, working top can be removed for easier handling during installation (in case of narrow doors).

- Internal and external doors, front and side panels and removable worktop in AISI 304 Stainless steel.
- External bottom panel in stainless steel.
- External back panel in galvanized steel.
- Built-in refrigeration unit.

- Fault code display.
- Mounted on Stainless steel legs to give 150 mm clearance for ease of cleaning the floor.

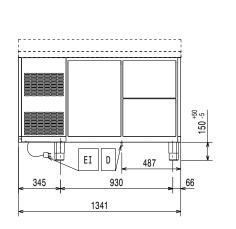

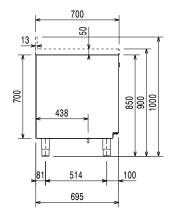

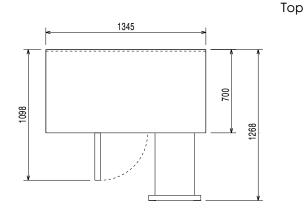
