Constructed entirely in 304 AISI stainless steel. No worktop. High-density expanded polyurethane foam, 50 mm in thickness, with cyclopentane injection. Height-adjustable feet. Lower refrigerated compartment designed to accommodate GN 1/1 containers and equipped with N.1 hinged door and N.2 drawers. Built-in refrigeration unit. Ventilated. Refrigerant R290. Digital control panel. Automatic evaporation of defrost water. Drain outlet. Suitable to operate in ambient temperatures up to +43°C. Temperature range: +2+10°C. CFC and HCFC free.

- Adjustable temperature range from 2 °C to 10 °C to suit meat, fish and dairy storage requirements.
- Forced air circulation for rapid cooling and an even temperature distribution.
- Automatic evaporation of defrost water. Prearrangement for drain outlet.





Front




Side



### EU energy labelling from 1st July 2016
