Constructed entirely in 304 AISI stainless steel. No worktop. High-density expanded polyurethane foam, 50 mm in thickness, with cyclopenthane injection. Height-adjustable feet. Lower refrigerated compartment designed to accommodate GN 1/1 containers and equipped with N. 2 hinged doors. Built-in refrigeration unit. Ventilated. Refrigerant R290. Digital control panel. Automatic evaporation of defrost water. Drain outlet. Suitable to operate in ambient temperatures up to +43°C. Temperature range: +2+10°C. CFC and HCFC free.






